IMPOSITION OF RATES AND FEE FIXING RESOLUTION, 2026

ADA EAST DISTRICT ASSEMBLY

Resolved that by virtue of section 137 (1),141 (1) of the Local Government Act, 2016 (Act 936) and the Guidelines for charging of Fees for the Provision of Services and facilities and granting of Licences and Permits by Metropolitan/Municipal/District Assemblies, the following Fees shall be charged by the Ada East District Assembly for the Financial Year 1st January, 2026 to 31st December, 2026.

Under section 146 (2), of the Act, a Basic Rate of five Ghana Cedis (5.00) per male and female shall be payable by all persons of 18years and above, but below the age of seventy (70) years who reside within, or own immovable property situated within the area of Authority of the Ada East District Assembly.

In addition to the Basic Rate, property owners shall be charged a General Rate per cedi of the rateables value of immovable property situated within the administrative area of the Ada East District Assembly except properties from rating under the provision of section 146(2) of the Act. The amounts shall be set out in the following.

Notes

- "Advertisement" means any word, letter, logo, figure, symbol, product-replica, cut-out, picture or combination thereof, relating to the name or services or products of a business, corporate entity, trade, partnership, individual; or any information, recommendation or exhortation pertaining to a service, product, campaign or event; and "Advertise" and "Advertising" have a corresponding meaning.
- Fees will be charged, and permits will be given in accordance with guidelines that may be issued from time to time by AEDA.

Fees are chargeable on the owner of, and/or the person advertising on, the signage, billboard or other advertisement structure.

- Any person whose name appears on an unauthorized sign or whose product or services are advertised on such sign, shall be the owner of such sign and shall be liable for any default fees/charges, until the contrary is proved by that person.
- Any person that is the owner of land or building on which any unauthorized sign is displayed, shall be deemed the owner of such and shall be liable for any default fees/charges, until the contrary is proved by that person.
- A business operating permit is required by any owner of a sign or advertisement structure advertising the products, services, events etc. of another person, except where the sign or advertisement structure is on the business premises or venue carrying on the business of the advertised products, services, event etc.

Note 1

The charges stipulated in this item fall under two main classifications:

- "Levies" which used to be charged by the Ministry of Energy and Mines based on the capacity of the filling or service station and which the Ministry of Energy and Mines has now authorized the District Assembly to collect and retain as revenue. These levies are what have been indicated in (a) under the item.

"Business Operating Permit Fees" which are charged annually by the District Assembly to various filling and service stations in accordance with the Ada East District Assembly (Business Operating Permit) Bye-law (2023). These Permit Fees are shown in (b) of the item,

The above exposition presupposes that those businesses in (b) pay the levies in (a) as well depending on the capacity of the station.

- Any arrears outstanding after the due date for settlement shall attract a penalty of 30% of the amount owned

Note 3

It shall be the duty of every person liable to pay an operating permit fee and/or any annual fees to settle the amount thereof at the offices Of the Ada East District Assembly on or before 31st March 2026.

Notes 4

The minimum fee to run a private car park (e.g. Underground Car Park) is Five Thousand, Three Hundred and Twenty-Four Ghana Cedis (GHÉ5,324.00) per annum. This excludes Business Operating Permit Fees.

Note 5

The Special Trade Permit Stickers and sellers ID card will be required by any truck, vendor, company, seller that shall trade in the Ada East District Assembly Area. Stickers shall be issued one per truck per annum and shall expire at the end of every year irrespective of the date that it was issued. Sellers ID Tag shall be issued one per person per quality and shall expire at the end of every quarter irrespective of the date that was issued.

All Mineral and Filtered Drinking Water Producers, Alcoholic and Non-Alcoholic Beverages Producers, Ice Cream Producers, Cocoa Drink, Bread, Plastic Shopping, Carry Bags, Plastic Rolls & Sheering, Ice Water/Cocoa Drink/Ice Cream/Bread Sellers who shall do Business and or trade in the Ada East Area will be required to Register with the District Assembly, and apply for a AEDA Certificate Permit or Seller ID Tag. Before you are issued with a Permit, the company must provide the following:

- Business Registration Certificate

Certificate to Commence Business

AEDA Business Operating Permit

Ghana Standard Board or Food & Drugs Board Certificate

- Full Business Address & Contract Details
